**Nominating Process**

*Question: How does the presbytery populate our committees and elect officers?*

Answer: This presbytery has established two normal ways of populating a committee: first, by electing a man who is nominated from the floor of Presbytery (Manual 5-2.5), or by electing a man who is nominated at Presbytery by the nominating committee (Manual 5-8.6). Officer nominations and elections occur in the same manner.

*Question: What happens if someone resigns from a committee, and when do committee members rotate off of permanent committees?*

Answer: If someone resigns from a committee, the Moderator has authority to replace them. These replacements must have the consent of the next court meeting (Manual 4-2.5). These replacements remain in office until the next annual February election (Manual 4-2.5). In general, committee officers rotate off after the February meeting of their class year (Manual 4-1.3).

*Question: When do officer and committee elections take place?*

Answer: All Presbytery officers, permanent committee members, GA CoC's, a Floor Clerk, and a Lord's Supper RE are *nominated* at the February meeting (Manual 4-1.3; 5-8.6), and all aside from the Vice-Moderator are *elected* at the same meeting. The Vice-Moderator is *elected* at the May meeting (Manual 4-1.2). GA RPR, Nominating Committee, and permanent committees and agencies are nominated at the November Presbytery meeting.
